# **SPORTSMANSHIP**

#### PENALTIES ASSESSED

The following penalties were assessed for various violations of the IHSAA By-Laws:

Alexandria High School – Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (Girls Basketball and softball player participated without an approved transfer report being ruled upon)

- 1. The Alexandria High School girls' basketball and softball programs are issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.

3. In accordance with Rule 3-9 of the IHSAA By-Laws, the games the ineligible student participated in shall be forfeited if Alexandria was victorious. Alexandria High School is instructed to inform all schools involved of this violation

Angola High School – Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (Football players gathered on Sunday to play flag football in presence of high school coach)

- 1. The Angola High School football program issued a warning.
- 2. Coach Luke Amstutz is reprimanded for allowing these violations to occur.

Charlestown High School – Commissioner Cox reported the following action as a result of a violation of Rule 15-2.5a (Girls' basketball coach conducted open facility program in excess of three times a week)

- 1. The Charlestown High School girls' basketball program is issued a warning.
- 2. Coach Sam Terrell is reprimanded for causing this violation to occur.

Concord High School – Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (Boys' track athlete participated in several meets without an approved transfer report being ruled upon)

- 1. The Concord High School boys' track and field program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the scores of the meets the ineligible student participated in shall be recalculated to remove all points acquired by the ineligible athlete. Concord High School is instructed to inform all schools involved of this violation and the refigured scores.

Concord High School – Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (Girls' track athlete participated in several meets without an approved transfer report being ruled upon)

- 1. The Concord High School girls' track and field program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the scores of the meets the ineligible student participated in shall be recalculated to remove all points acquired by the ineligible athlete. Concord High School is instructed to inform all schools involved of this violation and the refigured scores.

Connersville High School – Commissioner Cox reported the following action as a result of a violation of Rule 15-1.2f (Baseball player participated in a tryout at a college during the authorized contest season)

- 1. The Connersville High School baseball program is issued a warning.
- The student athlete who participated in this tryout session during the contest season shall be suspended for two games. Games suspended prior to this communication shall count toward meeting said penalty.

Crawford County High School – Commissioner Cox reported the following action as a result of a violation of Rule 19-3 (Girls' track athlete participated without an approved transfer report being ruled upon)

- 1. The Crawford County High School girls' track and field program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the scores of the meets the ineligible student participated in shall be recalculated to remove all points acquired by the ineligible athlete. Crawford County High School is instructed to inform all schools involved of this violation and the refigured scores.

Eminence High School – Commissioner Cox reported the following action as a result of a violation of Rule 18-1 (Baseball player participated in several games while academically ineligible)

- 1. The Eminence High School baseball program is issued a warning
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until he meets the minimum standards for academic eligibility.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, Eminence High School shall notify the schools against whom the ineligible athlete competed of this violation and the games shall be forfeited if Eminence was victorious.

Evansville Reitz Memorial High School – Commissioner Cox reported the following action as a result of a violation of Rule 9-13 (Volunteer girls' tennis coach participated in hitting sessions with players on Sunday)

- 1. The Evansville Reitz Memorial High School girls' tennis program is issued a warning.
- 2. Coach Ray Trapp is reprimanded for allowing this violation to occur. It is imperative that all coaches review the provisions of the IHSAA by-laws with all assistant and volunteer coaches regarding both participation rules and Sunday participation.
- 3. Coach Lee Sublett is severely reprimanded for allowing this violation to occur.

Fishers High School – Commissioner Cox reported the following action as a result of a violation of Rule 15-2.5 (A student not enrolled at Fishers participated in a boys' basketball open facility program during the school year out of season)

- 1. The Fishers High School boys' basketball program is issued a warning.
- 2. Coach Joe Leonard is reprimanded for causing this violation to occur.

Griffith High School – Commissioner Cox reported the following action as a result of a violation of Rule 3-10 (Student participated in several baseball games without a current pre-participation physical and consent form submitted)

- 1. The Griffith High School baseball program is issued a warning.
- 2. Coach Brian Jennings is reprimanded for allowing this violation to occur.
- 3. This is a health and safety issue and it is absolutely imperative that the "IHSAA Pre-Participation Evaluation Form" complete in every detail be on file for all student athletes prior to their participation in a practice.
- 4. The games in which the student athlete participated in while ineligible shall be forfeited. Griffith High School shall notify all schools of these forfeitures.

Hamilton Southeastern High School – Commissioner Cox reported the following action as a result of a violation of Rule 15-1.1 (Boys' golfer participated in a non-school sponsored event during the authorized contest season without an approved waiver)

- 1. The Hamilton Southeastern High School boys' golf program is issued a warning.
- 2. The student athlete who participated in this non-school tournament shall be suspended from participation in two boys' golf matches.

Harrison (West Lafayette) High School – Commissioner Cox reported the following action as a result of a violation of 3-9.4 (Baseball player participated in sectional game without being entered on sectional entry list)

- 1. The Harrison High School baseball program is issued a warning.
- 2. Coach Bryan VanZile is reprimanded for allowing this violation to occur. Only those players listed on the official entry should even be allowed to dress for the tournament series; they certainly should not be allowed to participate.
- The student athlete involved is disqualified from the IHSAA baseball tournament series.
   It is strongly suggested that future sectional entry lists be reviewed with the utmost care and posted conspicuously in locker rooms for student athletes to review before submission to the IHSAA.

Homestead High School – Commissioner Cox reported the following action as a result of a violation of 15-2.2a (Five boys' basketball players participated together on a non-school sponsored team during the school year out of season)

- 1. The Homestead High School boys' basketball program is issued a warning.
- 2. The five student athletes involved in this violation shall be suspended for two games each in the 2011-12 boys' basketball season. These suspensions may be spread out among the students over the first four regularly scheduled contests at Homestead High School.

Indiana School For the Deaf – Commissioner Cox reported the following action as a result of a violation of 9-16 (Baseball team forfeited sectional contest to Indianapolis Lutheran for failure to appear with sufficient number of players - PROBATION)

1. The Indiana School for the Deaf baseball program is placed on probation through the conclusion of the 2011-12 regular season. This probation is a severe type of warning. It is official notice that

serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.

- 2. The Indiana School for the Deaf shall remit a penalty of \$200.00 to the IHSAA as per the written policy contained within the IHSAA Spring Bulletin, Vol. 107, No. 3, Page 164.
- 3. Coach Rusty Crace is reprimanded for allowing this violation to occur.

Indianapolis Crispus Attucks High School – Commissioner Cox reported the following action as a result of a violation of 19-3 (Boys' golfer participated in several matches without an approved transfer report being ruled upon)

- 1. The Indianapolis Crispus Attucks High School boys' golf program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the scores of the matches the ineligible student participated in shall be recalculated to remove the individual scores acquired by the ineligible athlete. Indianapolis Crispus Attucks High School is instructed to inform all schools involved of this violation and the refigured scores.

Indianapolis Northwest High School – Commissioner Cox reported the following action as a result of a violation of 9-16 (Baseball team forfeited sectional contest to Indianapolis Bishop Chatard for failure to appear - PROBATION)

- 1. The Indianapolis Northwest High School baseball program is placed on probation through the conclusion of the 2011-12 regular season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. Indianapolis Northwest High School shall remit a penalty of \$200.00 to the IHSAA as per the written policy contained within the IHSAA Spring Bulletin, Vol. 107, No. 3, Page 164.
- 3. Coach Justin Gingerich is reprimanded for allowing this violation to occur.

Merrillville High School – Commissioner Cox reported the following action as a result of a violation of 15-2.2a (Four girls' basketball players participated together on an AAU team in excess of the limitations provided in the rule)

- 1. The Merrillville High School girls' basketball program is issued a warning.
- 2. The student athletes involved in this violation shall be suspended from participation in one girls' basketball game at the start of the 2011-12 season. It is the school's prerogative to stagger these suspensions over the first three games of the season.

North Knox High School – Commissioner Cox reported the following action as a result of a violation of 15-2.3b (Camp fees were paid by school corporation funds for students to attend wrestling camps in 2007 and 2009 – PROBATION)

- 1. The North Knox High School wrestling program is placed on probation through the 2011-12 season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. Coach Butch Bryer is severely reprimanded for allowing these violations to occur.

Pendleton Heights High School – Commissioner Cox reported the following action as a result of a violation of 19-3 (Softball player participated in several softball contests without an approved transfer report being ruled upon)

- 1. The Pendleton Heights High School softball program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. Athletic Director John Broughton is reprimanded for not insuring that a transfer eligibility ruling was issued for this student.
- 4. Under Rule 16-3 of the IHSAA By-Laws, Pendleton Heights High School has suggested an alternate penalty to forfeiture of contests as the transfer report was filed in August of 2010 yet was never ruled upon by the IHSAA and confirmation of eligibility not established.
- 5. The IHSAA accepts Pendleton Heights' suggested penalty of a monetary fine of \$500.00 in lieu of forfeiture of contests.

Penn High School – Commissioner Cox reported the following action as a result of a violation of 15-2.2d (Assistant boys' basketball coach coached a girls' basketball player in an AAU game)

- 1. The Penn High School girls' basketball program is issued a warning.
- 2. The assistant coach (Hassan Abdullah) involved in this violation is reprimanded for allowing this violation to occur.

Plymouth High School – Commissioner Cox reported the following action as a result of a violation of 15-2.2a (Seven boys' soccer players participated together on a non-school sponsored team during the school year out of season)

- 1. The Plymouth High School boys' soccer program is issued a warning.
- 2. The seven student athletes involved in this violation shall be suspended for two games each in the 2011-12 boys' soccer season. These suspensions may be spread out among the students over the first four regularly scheduled contests at Plymouth High School.

Prairie Heights High School – Commissioner Cox reported the following action as a result of a violation of 15-1.1a (Boys' golfer participated in a non-school sponsored event without an approved waiver)

- 1. The Prairie Heights High School boys' golf program is issued a warning.
- 2. The student athlete who participated in this non-school sponsored event shall be suspended from participation in two boys' golf matches.

Providence High School – Commissioner Cox reported the following action as a result of a violation of 15-1.2c (Boys' basketball program practiced with alumni members)

- 1. The Providence High School boys' basketball program is issued a warning.
- 2. Coach Lou Lefevre is severely reprimanded for allowing this violation to occur.

Randolph Southern High School – Commissioner Cox reported the following action as a result of a violation of 19-3 (Softball player participated in a contest without an approved transfer report being ruled upon)

- 1. The Randolph Southern High School softball program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Transfer Report" be submitted and acted upon by the Association prior to a student being allowed to participate in a contest at their new school.
- 3. It is imperative that when receiving students from other schools, the academic progress is reviewed to insure eligibility.
- 4. In accordance with Rule 3-9 of the IHSAA By-Laws, the games the ineligible student participated in shall be forfeited if Randolph Southern was victorious. Randolph Southern High School is instructed to inform the school involved of this violation.

Rochester High School – Commissioner Cox reported the following action as a result of a violation of 15-1.2c (Baseball team took batting practice against alumni pitching)

- 1. The Rochester High School baseball program is issued a warning
- 2. Coach Brian Hooker is reprimanded for allowing this violation to occur.

Rock Creek Academy – Commissioner Cox reported the following action as a result of a violation of 3-9.4 (Two students participated in the baseball sectional without being listed on the official entry list)

- 1. The Rock Creek Academy baseball program is issued a warning.
- Coach Bill Paro is reprimanded for allowing this violation to occur. Only those players listed on the official entry should even be allowed to dress for the tournament series; they certainly should not be allowed to participate.
- 3. It is strongly suggested that future sectional entry lists be reviewed with the utmost care and posted conspicuously in locker rooms for student athletes to review before submission to the IHSAA.
- 4. Rock Creek Academy shall remit a penalty of \$500.00 to the IHSAA for their violation of Rule 3-9.4.

Roncalli High School – Commissioner Cox reported the following action as a result of a violation of 15-1.1 (Boys' golfer participated in a non-school sponsored event during the authorized contest season without an approved waiver)

- 1. The Roncalli High School boys' golf program is issued a warning.
- 2. The student athlete who participated in this non-school tournament shall be suspended from participation in two boys' golf matches.

South Central (Union Mills) High School – Commissioner Cox reported the following action as a result of a violation of 51-4 (Baseball player exceeded number of innings allowed as a pitcher in a three day period)

- 1. The South Central baseball program is issued a warning.
- 2. The student athlete involved shall be limited to no more than nine innings of pitching in the next three day period to account for the extra inning of pitching.
- 3. South Central shall forfeit the contest in which the pitcher exceeded the limitations provided for in Rule 51-4 if South Central was victorious and shall notify the opposing school of such forfeiture.

South Spencer High School – Commissioner Cox reported the following action as a result of a violation of 9-14c (Softball player participated in a contest after missing ten consecutive days of practice without completion of six days of required practice)

- 1. The South Spencer High School softball program is issued a warning.
- 2. Coach Chris Dawson is reprimanded for causing this violation to occur. Rule 9-14 provides safeguards for student athletes returning to competition after illness or injury and should be strictly adhered to.
- 3. In accordance with Rule 3-9, South Spencer High School shall forfeit the junior varsity contest in which the ineligible athlete participated if South Spencer was victorious and notify the school of such forfeiture.

Southwestern (Shelby) High School – Commissioner Cox reported the following action as a result of a violation of 9-16 (Softball team forfeited sectional contest to Eminence for failure to appear with sufficient number of players - PROBATION)

- 1. The Southwestern High School softball program is placed on probation through the conclusion of the 2011-12 regular season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. Southwestern High School shall remit a penalty of \$200.00 to the IHSAA as per the written policy contained within the IHSAA Spring Bulletin, Vol. 107, No. 3, Page 185.
- 3. Coach Brett Griffey is reprimanded for allowing this violation to occur. Ignorance of IHSAA policy or by-laws is no excuse for violating stated policy.

White River Valley High School – Commissioner Cox reported the following action as a result of a violation of 18-1 (Boys' track athlete participated in a meet while academically ineligible)

- 1. The White River Valley High School boys' track and field program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until he meets the minimum standards for academic eligibility.
- In accordance with Rule 3-9 of the IHSAA By-Laws, the schools which this ineligible athlete competed
  against shall be notified of this violation. Additionally, the meet scores shall be recalculated after
  forfeiting the ineligible athlete's places.

Winamac High School – Commissioner Cox reported the following action as a result of a violation of 9-13 (Boys' assistant track coach worked with a member of the girls' track team on Sunday)

- 1. The Winamac High School girls' track program is issued a warning.
- 2. Coach Adam Bennett is reprimanded for allowing this violation to occur. It is imperative that all coaches review the provisions of the IHSAA by-laws with all assistant and volunteer coaches regarding both participation rules and Sunday participation.
