East Chicago Central High School

Commissioner Cox reported the following action as a result of a violation of Rule Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- 1. The East Chicago Central Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.

- 3. The contest was stopped during the third quarter and was never restarted. This contest shall be omitted from the schedules of both schools and no result shall be recorded for said contest.
- 4. The administration of East Chicago Central High School will continue to work with the boys' basketball program to insure acts of this nature are eliminated with a focus on proper behaviors in an education based athletic setting.

Gary Wallace High School

Commissioner Cox reported the following action as a result of a violation of Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- The Gary Lew Wallace Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.
- 3. The contest was stopped during the third quarter and was never restarted. This contest shall be omitted from the schedules of both schools and no result shall be recorded for said contest.
- 4. The administration of Gary Lew Wallace High School will continue to work with the boys' basketball program to insure acts of this nature are eliminated with a focus on proper behaviors in an education based athletic setting.

Indianapolis Crispus Attucks High School

Commissioner Cox reported the following action as a result of a violation of Rule 15-1.2c. (Students from another school participated in a school practice session.)

- 1. The Indianapolis Crispus Attucks High School boys' basketball program is issued a warning.
- 2. Coach Victor Chukwudebe is severely reprimanded for allowing this violation to occur.

Indianapolis Metropolitan High School

Commissioner Cox reported the following action as a result of a violation of Rule 3-9.4 (Student participated in boys' basketball semi state that was not listed on the sectional entry list.)

- 1. The Indianapolis Metropolitan High School boys' basketball program is issued a warning.
- 2. Coach Nick Reich is reprimanded for allowing this violation to occur. Only those players listed on the official entry should even be allowed to dress for the tournament series; they certainly should not be allowed to participate.
- 3. The student athlete involved in this rule violation shall be suspended from further participation.
- 4. It is strongly suggested that future sectional entry lists be reviewed with the utmost care and posted conspicuously in locker rooms for student athletes to review before submission to the IHSAA.
- 5. Indianapolis Metropolitan High School shall remit a penalty of \$500.00 to the IHSAA for their violation of Rule 3-9.4.

Lafayette Central Catholic High School

Commissioner Cox reported the following action as a result of a violation of Rule 15-2-2 (Seven girls' basketball players participated together on a non-school sponsored team)

- 1. The Lafayette Central Catholic High School girls' basketball program is issued a warning.
- The seven student athletes involved in this violation shall be suspended for two games each in the 2011-12 girls' basketball season. These suspensions may be spread out among the students over the first four regularly scheduled contests at Lafayette Central Catholic.

Lawrence North High School

Commissioner Cox reported the following action as a result of a violation of Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- 1. The Lawrence North Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.
- The administration of Lawrence North High School will continue to work with the boys' basketball
 program to insure acts of this nature are eliminated with a focus on proper behaviors in an
 education based athletic setting.

North Central (Indianapolis) High School

Commissioner Cox reported the following action as a result of a violation of Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- 1. The North Central Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.
- 3. The IHSAA accepts the suspension of D'Vauntes Smith-Rivera from the first game of the boys' basketball regional on March 12, 2011 vs. Pike High School as appropriate penalty for actions committed in the contest of record.
- 4. The administration of North Central High School will continue to work with the boys' basketball program to insure acts of this nature are eliminated with a focus on proper behaviors in an education based athletic setting.

North Newton High School

Commissioner Cox reported the following action as a result of a violation of Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- 1. The North Newton Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.
- 3. The administration of North Newton High School will continue to work with the boys' basketball program to insure acts of this nature are eliminated with a focus on proper behaviors in an education based athletic setting.

South Bend Adams High School

Commissioner Cox reported the following action as a result of a violation of Rule 52-8 (Girls' basketball player played in three weeknight contests)

- 1. The South Bend Adams girls' basketball program is issued a warning.
- 2. Coach Steve Scott is reprimanded for allowing this violation to occur.
- 3. The junior varsity game in which this violation occurred (Dec. 2, 2010) shall be forfeited to South Bend Clay High School if South Bend Adams was victorious.

Union (Modoc) High School

Commissioner Cox reported the following action as a result of a violation of Rule 3-10 (Two track and field athletes participated in practice without a completed IHSAA pre-participation physical and consent form completed and submitted)

- 1. The Union High School track and field program is issued a warning.
- 2. Coach Ryan Fathauer is reprimanded for allowing this violation to occur.
- 3. This is a health and safety issue and it is absolutely imperative that the "IHSAA Pre-Participation Evaluation Form" complete in every detail be on file for all student athletes prior to their participation in a practice.

Western Boone High School

Commissioner Cox reported the following action as a result of a violation of Rule 15-2-2c (Volunteer assistant softball coach provided a private lesson to student athlete)

- 1. The Western Boone High School softball program is issued a warning.
- Coach Todd Clark is reprimanded for allowing this violation to occur. It is imperative that the head coach exert institutional control over his assistant coaches and that all staff members have a clear understanding of the by-laws regarding contact with student athletes during the school year out of season.

Whiting High School

Commissioner Cox reported the following action as a result of a violation of Rules 3-6 & 8.1 (Multiple players left bench area during altercation in boys' varsity basketball game – PROBATION)

- 1. The Whiting Boys' Basketball program is placed on probation through the conclusion of the 2011-12 winter season. This probation is a severe type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will not be tolerated.
- 2. The suspensions issued and already served are accepted by the IHSAA as immediate sanctions imposed on offending individuals.
- 3. The administration of Whiting High School will continue to work with the boys' basketball program to insure acts of this nature are eliminated with a focus on proper behaviors in an education based athletic setting.
