#### **SPORTSMANSHIP**

Assistant Commissioner Wynns updated the Executive Committee on the unsportsmanlike conduct reports that have been submitted. As of December 1, 2010, there have been 415 reports filed. This figure shows a slight increase over last year's numbers.

### **FINANCIAL REPORTS**

The following reports were presented regarding the financial status of sports conducted during the fall sports season.

- 1. The Girls Golf tournament series produces little income. The costs related to greens fees were significantly higher than last year.
- 2. Boys Tennis is a non-revenue generating sport. The cost of the Boys Tennis Tournament Series showed an decrease of expenditures from last year.
- 3. The Boys and Girls Cross Country Tournament Series expenses showed a slight increase in expenditures.
- 4. The Boys and Girls Soccer tournament attendance increased, primarily due to positive weather, as is reflected in the increase of net revenue.
- 5. The Volleyball tournament series added an additional level of play. The net revenue showed an increase in attendance at all levels of the tournament.

### LITIGATION

Attorney Robert Baker updated the Executive Committee on the current status of pending litigation against the Association.

## **DISTRICT II MEDIA AWARD**

Dave Calabro of WTHR-TV Channel 13 in Indianapolis was named the recipient of the 2010-11 IHSAA Distinguished Media Service Award for District II. As Sports Director for WTHR-TV, Calabro appears virtually seven days a week on Channel 13. He anchors sports on weeknights on Eyewitness News and hosts the popular "13 SportsJam" Sunday nights at 11:20 pm. During the high school seasons, Calabro's "Operation Football", with its frequent helicopter stops across the area, and "Operation Basketball" features have become highly popular with viewers all over central Indiana. Calabro joined WTHR-TV in May of 1992 as weekend sports anchor. During his time there, he has covered high school and college sports, the Colts, the Pacers and Olympic games all over the world. Before coming to WTHR, he worked for five years at WDTN-TV in Dayton, Ohio where he covered Bengals football and Reds baseball as the sports anchor.

## **PENALTIES ASSESSED**

Ben Davis High School – (Volleyball player participated in several junior varsity matches without transfer being approved). Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The Ben Davis High School volleyball program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible student athlete competed shall be notified of this violation and the matches shall be forfeited if Ben Davis was victorious.

Christian Academy of Indiana – (Wrestler participated in an invitational without ten practices).

Commissioner Ress reported the following action as a result of a violation of Rule 50-1.

- 1. The Christian Academy of Indiana wrestling program is issued a warning.
- Coach Mike Brown is reprimanded for allowing this violation to occur. Ignorance of the rules is not an acceptable explanation for a rules violation.
- 3. In accordance with Rule 3-9, the schools against which this ineligible student participated shall be notified of this rule violation, and the meet scores shall be recalculated after forfeiting the matches in which the ineligible wrestler participated.

East Noble High School - (Girls' swimmer participated in two meets without transfer being approved).

Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The East Noble High School girls' swimming & diving program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the meet scores shall be recalculated after forfeiting the places and points awarded the ineligible swimmer and moving everyone else up. The schools she competed against shall be notified of this violation and the recalculated meet scores.

Ft. Wayne Wayne High School – (Football player participated on the junior varsity football team without transfer being approved). Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The Fort Wayne Wayne High School football program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible student participated shall be notified of this violation and the games shall be forfeited if Fort Wayne Wayne was victorious.

Goshen High School – (Foreign student who had completed 8 semesters of high school participated on junior varsity boys' cross country team without transfer report being submitted).

Commissioner Ress reported the following action as a result of a violation of Rule 12-2 and 19-7.

- 1. The Goshen High School boys' cross country program is issued a warning
- 2. It is absolutely mandatory that the "IHSAA Foreign Exchange Student Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible student competed shall be notified of this violation and the meet scores shall be recalculated after removing the time and place of the ineligible runner.
- 4. Athletic Director Larry Kissinger is reprimanded for failing to submit a transfer report in a timely fashion thus allowing an ineligible student to participate for an entire athletic season.

Griffith High School – (Girls' basketball player exceeded the five quarter limit in junior varsity and varsity doubleheader).

Commissioner Ress reported the following action as a result of a violation of Rule 102c(3).

- 1. The Griffith High School girls' basketball program is issued a warning.
- 2. Coach Tom Golumbeck is reprimanded for allowing this violation to occur.
- 3. All six quarters shall count against the maximum number of quarters allowed for the student athlete involved in this violation.
- 4. The game in which this violation occurred shall be forfeited to River Forest High School if Griffith was victorious.

Indianapolis Chatard High School – (*Ineligible girls' basketball player participated in a scrimmage versus a member school*). Commissioner Ress reported the following action as a result of a violation of Rule 19-4.

- 1. The Indianapolis Chatard High School girls' basketball program is issued a warning.
- 2. Coach Bill Silvey is reprimanded for allowing this rules violation to occur
- 3. The student athlete involved in this violation is ineligible to participate in any contests during the 2010-11 school year.
- 4. In accordance with Rule 3-9 of the IHSAA By-Laws, Tindley Charter School shall be notified of this violation.

Jay County High School – (*Two girls' swimmers were allowed to practice without completed physical form being turning in*). Commissioner Ress reported the following action as a result of a violation of Rule 3-10.

- 1. The Jay County High School girls' swimming and diving program is issued a warning.
- 2. This is a health and safety issue and it is absolutely imperative that "Consent & Release Certificates" be on file for all student athletes prior to their participation in a practice..

Pike High School – (Girls' basketball coach allowed non-feeder school student to attend open facility sessions).

Commissioner Ress reported the following action as a result of a violation of Rule 15-2.5 and 20-6.

- 1. The Pike High School girls' basketball program is issued a warning.
- 2. Coach Robert Anglea is severely reprimanded for causing these violations to occur.
- 3. The IHSAA supports the one game suspension of Coach Anglea as an appropriate reaction to this violation.

Pioneer High School – (Two boys' basketball players participated on a non-school YMCA team during contest season).

Commissioner Ress reported the following action as a result of a violation of Rule 15-1.2.

- 1. The Pioneer High School boys' basketball program is issued a warning.
- 2. The student athletes involved in this violation shall be suspended for two games.

Providence High School – (Softball coach conducted open facility sessions more frequently than allowable).

Commissioner Ress reported the following action as a result of a violation of Rule 15-2.5a.

- 1. The Providence High School softball program is issued a warning.
- 2. Coach Sean Payne is reprimanded for causing this violation to occur.
- 3. The IHSAA supports the suspension of open facility sessions for the remainder of 2010 as an appropriate reaction to this violation.

Southwestern (Shelby) High School – (Soccer player participated after submitting physical form that had been forged).

Commissioner Ress reported the following action as a result of a violation of Rule 3-10.

- 1. The Southwestern High School soccer program is issued a warning.
- 2. This is a health and safety issue and it is absolutely imperative that "IHSAA Pre-Participation Evaluation Form," complete in every detail, be on file for all student athletes prior to their participation in a practice.
- 3. The IHSAA accepts and supports as an appropriate penalty the suspension of the student athlete that submitted a physical form that included a doctor's signature that had been forged.
- 4. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible student participated shall be notified of this violation and the soccer matches shall be forfeited if Southwestern was victorious.

Southwestern (Shelby) High School – (Girls' basketball player participated in three games after submitting physical form that had been forged).

Commissioner Ress reported the following action as a result of a violation of Rule 3-10.

- The Southwestern High School girls' basketball program is issued a warning.
- 2. This is a health and safety issue and it is absolutely imperative that "IHSAA Pre-Participation Evaluation Form," complete in every detail, be on file for all student athletes prior to their participation in a practice.
- 3. The IHSAA accepts and supports as an appropriate penalty the suspension of the student athlete that submitted a physical form that included a doctor's signature that had been forged.
- 4. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible student participated shall be notified of this violation and these girls' basketball games shall be forfeited if Southwestern was victorious.
