Attorney Robert Baker updated the Executive Committee on the current status of pending litigation against the Association.

#### **PENALTIES ASSESSED**

Anderson High School – (*Academically ineligible volleyball player participated in several matches*). Commissioner Ress reported the following action as a result of a violation of Rule 18-1.

- 1. The Anderson High School volleyball program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until she meets the minimum standards for academic eligibility.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, Anderson High School shall notify the schools against whom this ineligible athlete completed of this violation and the matches shall be forfeited if Anderson was victorious.

Blackford High School – (*Academically ineligible football player participated in three junior varsity games*). Commissioner Ress reported the following action as a result of a violation of Rule 18-1.

- 1. The Blackford High School football program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until she meets the minimum standards for academic eligibility.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, Blackford High School shall notify the schools against whom this ineligible athlete competed of this violation and the games shall be forfeited if Blackford was victorious.

Centerville High School – (*Softball coach coached team including players from his team during the school year out-of-season & he coached them on a Sunday*). Commissioner Ress reported the following action as a result of a violation of Rule 9-13 and 15-2.2d.

- 1. The Centerville High School softball program is issued a warning
- 2. Coach Bill Gray is severely reprimanded for causing multiple violations to occur

Chesterton High School – (*Football player exceeded the 5 quarter limit in junior varsity and varsity combination*). Commissioner Ress reported the following action as a result of a violation of Rule 54-3.1.

- 1. The Chesterton High School football program is issued a warning.
- 2. Junior Varsity Coach Craig Jones is reprimanded for allowing this violation to occur. The IHSAA accepts and supports as appropriate the one game suspension of Coach Jones.
- 3. All guarters played shall count against the maximum number of quarters allowed for the student athlete involved in this violation.
- 4. In accordance with Rule 3-9, Crown Point High School shall be notified of this violation and if Chesterton was victorious, the game shall be forfeited.

Fort Wayne Wayne High School – (*Two coaches and four players ejected during incident in sectional football game-PROBATION*). Commissioner Ress reported the following action as a result of a violation of Rule 3 and 8.

- The Fort Wayne Wayne athletic program is placed on probation through the 2011 fall contest season. This probation is a severe
  type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will
  not be tolerated.
- Based upon the actions and behaviors of those individuals within the Wayne athletic program from this point forward, a decision will be made after Week 6 on the 2011 football season on whether or not the Wayne High School football team may participate in the 2011 IHSAA Football Tournament series.
- 3. Coach Kyle Beauchamp shall be suspended for the first regular season game of the 2011 football season based on Rule 8-3 of the IHSAA By-Laws. Coach Beauchamp is not to be on the premises during the game when his suspension is being served.
- 4. As determined by the Wayne administration, Assistant Coach Robert McDonald shall receive a more severe penalty than assessed against Coach Beauchamp.

- 5. Due to the severity of the unsportsmanlike behaviors exhibited, the players who were ejected shall receive a penalty, determined by the Wayne administration, greater than a one game athletic suspension.
- 6. The school administration must adopt and implement a character building program within the school in an effort to change the current attitudes of student athletes regarding education based athletics and their role as a student athlete. All athletes will be required to participate in this program.
- 7. In all sports, parents will be required to attend a pre-season meeting addressing behavioral expectations for them and their children
- 8. The administration of Wayne High School is commended for the manner in which they have responded and investigated the incidents of October 22.

Fremont High School – (*Academically ineligible football player participated in two varsity games*). Commissioner Ress reported the following action as a result of a violation of Rule 18-1.

- 1. The Fremont High School football program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until he meets the minimum standards for academic eligibility.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible athlete competed shall be notified of this violation and the games shall be forfeited if Fremont was victorious.

Hammond High School – (*Football player with no remaining eligibility participated on football team-PROBATION*). Commissioner Ress reported the following action as a result of a violation of Rule 12-2.

- The Hammond High School football program is placed on probation through the 2011 football season. This probation is a severe
  type of warning. It is official notice that serious violations have occurred, are a matter of record and future, similar incidents will
  not be tolerated.
- The student athlete involved in this violation shall be suspended and declared ineligible for further athletic competition in any sport.
- 3. In accordance with Rule 3-9, Hammond High School shall notify the schools against which this ineligible student athlete competed of this violation and if Hammond High School was victorious in any of the regular season games, those games shall be forfeited.
- 4. The football team may continue to compete in the IHSAA tournament series without the suspended player

Merrillville High School – (*Girls' soccer coach removed team from contest prior to the conclusion of the match*). Commissioner Ress reported the following action as a result of a violation of Rule 9-16.

- 1. The Merrillville High School girls' soccer program is issued a warning.
- 2. Coach Ben Daniel is severely reprimanded for causing this violation to occur.
- 3. The IHSAA accepts and supports the one match suspension of Coach Daniel as an appropriate response for this violation.
- 4. The administration of Merrillville High School is commended for its reporting and handling of this matter.

New Castle High School - (*Academically ineligible boys' soccer player participated in several matches*). Commissioner Ress reported the following action as a result of a violation of Rule 18-1.

- 1. The New Castle High School boys' soccer program is issued a warning.
- 2. The student athlete involved in this violation shall be suspended and declared ineligible for further competition until he meets the minimum standards for academic eligibility.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, New Castle High School shall notify the schools against whom this ineligible athlete completed of this violation and the matches shall be forfeited if New Castle was victorious.

Northview High School – (*Volleyball player returned to competition without an adequate number of practices*). Commissioner Ress reported the following action as a result of a violation of Rule 9-14.

- 1. The Northview High School volleyball program is issued a warning.
- 2. Coach Scott McDonald is reprimanded for allowing this violation to occur. This is a health and safety issue and it is absolutely imperative that student athletes do not return to competition without meeting the standards outlined in the by-laws.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, Danville High School shall be notified of this violation and the match shall be forfeited if Northview High School was victorious.

Plainfield High School – (*Academically ineligible football player participated in junior varsity game prior to certification date*). Commissioner Ress reported the following action as a result of a violation of Rule 18-1.

- 1. The Plainfield High School football program is issued a warning.
- 2. In accordance with Rule 3-9 of the IHSAA By-Laws, Mooresville High School shall notified of this violation and the junior varsity game shall be forfeited if Plainfield was victorious.

Rushville High School – (Football player participated in six J-V games without transfer being approved). Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The Rushville High School football program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.

3. In accordance with Rule 3-9 of the IHSAA By-Laws, the school against which this ineligible athlete participated shall be notified of this violation and the games shall be forfeited if Rushville was victorious.

South Bend Riley High School – (*Boys' soccer player participated in four matches without transfer being approved*). Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The South Bend Riley High School boys' soccer program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible athlete competed shall be notified of this violation and the matches shall be forfeited if South Bend Riley was victorious or if they ended in a tie.

Valparaiso High School – (*Football Boys' soccer player returned to competition without an adequate number of practices*). Commissioner Ress reported the following action as a result of a violation of Rule 9-14.

- 1. The Valparaiso High School boys' soccer program is issued a warning.
- 2. Coach Danny Jeftick is reprimanded for allowing this violation to occur. This is a health and safety issue and it is absolutely imperative that student athletes do not return to competition without meeting the standards outlined in the by-laws.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, LaPorte High School shall be notified of this violation and the match shall be forfeited if Valparaiso High School was victorious or if the match ended in a tie.

Wabash High School – (*Volleyball player participated in six sets versus same school on same day*). Commissioner Ress reported the following action as a result of a violation of Rule 111-4.

- 1. The Wabash High School volleyball program is issued a warning.
- 2. Coach Katie Cromer is reprimanded for permitting this violation to occur
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the varsity match versus Eastern (Greentown) High School shall be forfeited if Wabash was victorious.
- 4. Participation in six games shall count as two of permitted matches for this student athlete.

Western High School – (*Girls' soccer player participated in several matches without transfer being approved*). Commissioner Ress reported the following action as a result of a violation of Rule 19-3.

- 1. The Western High School girls' soccer program is issued a warning.
- 2. It is absolutely mandatory that the "IHSAA Athletic Transfer Report" be submitted and acted upon by the Association prior to a student athlete being allowed to participate in a contest at their new school.
- 3. In accordance with Rule 3-9 of the IHSAA By-Laws, the schools against which this ineligible athlete participated shall be notified of this violation and the matches shall be forfeited if Western High School was victorious or if the match ended in a tie.

Western Boone High School – (*Wrestling coach conducted practice session prior to Monday of Week 18*). Commissioner Ress reported the following action as a result of a violation of Rule 50.

- 1. The Western Boone High School wrestling program is issued a warning.
- 2. Coach Adam Logue is reprimanded for allowing this violation to occur.
